

## Delta Institute Weatherization Program

The Delta Institute has two great energy efficiency programs available that you may be eligible for.

**Delta Weatherization Home Energy Efficiency Program:** Delta Institute will work with a Home Energy Rating System (HERS) Rater to conduct an audit of your home and determine what work can be done to weather seal your home so as to reduce wasted energy and utilities bills.

Eligibility: This program is available for low to moderate income homeowners of detached homes\* (up to four units) within the City of Chicago. Applicants must make at least 30% of the area median income (AMI) up to 120%. To see if your household income qualifies please see the chart below.

\*We do not service historic bungalows that are registered with the Historic Chicago Bungalow –Initiative (HCBI) OR are eligible to register with HCBI. If you think you might own an historic bungalow, please call (312) 642-9900 to see if you qualify for their program.

**Delta Institute Appliance Program:** Delta will replace existing older and inefficient appliances. These appliances will be given in exchange for efficient EnergyStar appliances, and the old appliance will be properly recycled as part of the program. To apply for this program in addition to the Weatherization Program please complete the supplemental application.

Eligibility: This program is available for ComEd customers with a household income below 80% of Average Medium Income (AMI). To see if your household income qualifies please see the chart below.
