COMMUNITY-DRIVEN BROWNFIELD REDEVELOPMENT

Delta Institute takes a unique hybrid approach to brownfield redevelopment that involves site assessments coupled with on-the-ground community engagement. Delta directly engages with community members and stakeholders throughout the redevelopment process to act as a facilitator, translator, and reuse strategist for sustainable redevelopment of sites.

1 LAND PLANNING

The first consideration in our redevelopment process involves assessing the current land characteristics of the area.

2 COMMUNITY ASSETS

Local residents are involved in identifying important assets, including roadways, access points for public transportation, industrial and commercial corridors, cultural, educational, medical, and commercial institutions, throughout the neighborhood.

3 POTENTIAL REUSE SITES

Dozens of sites may initially be considered for redevelopment. Community-led site exploration and research as well as input on site reuse ideas can help prioritize sites for redevelopment.
